TERMS and CONDITIONS

The animal must have proper care and timely veterinary care. Must not be kept in a cage or free-range outdoors.

An animal may never be taken to a store or market for resale. And also resold without notifying the breeder.

The animal is sold as a PET class.

Declawing is prohibited!

Based on these provisions, the Parties have agreed on the following special terms of the contract:

1. All kittens delivered under this agreement are purebred and weaned before leaving for their new home.
2. Under no circumstances is this pet to be given, sold, leased, or consigned to any pet shop, reseller, research laboratory, or similar facility and will receive proper medical care from a licensed veterinarian, and recommend an exam within a week after taking the kitten home.
3. Specific diet and kitten care are provided which will maintain the health and vitality of the kitten(s). In addition, we recommend that you provide adequate toys, scratching posts, etc., and are available for advice if you have any questions.

4. Kitten(s)/cat(s) will provide a Veterinary health document(Neg FELV-FIV Blood Work), vaccination, shot records, microchip, spayed and neutered.
5. In the unlikely event, the breeder offers a replacement kitten if a genetic defect results in death up to the kitten's 1st Birthday. Upon written necropsy certification by a licensed veterinarian, whose services will be paid by the purchaser. A replacement kitten of equal value will be provided pending availability.
6. If the sold animal is noticed by the breeder in poor physical or unkempt condition, or it has been subjected to obvious physical violence, then the animal with all its registration and exhibition documents is subject to a non-refundable return without refund. Highly recommended to keep cats and kittens strictly at home to avoid future health problems.
7. The buyer has the right, within 3 days, at his own expense, to check the health of the animal in licensed veterinary institutions. The breeder undertakes to take back the animal with a one-time refund within 5 days from the date of sale with the presentation of a veterinary opinion confirming the animal's health at the time of purchase. (FeLV, FIV, and FIP are not genetic and are specifically excluded).
8. If the buyer has not exercised the right stipulated in clause 7, then claims for the condition of the animal will not be accepted in the future and a refund after a five-day guarantee given by the breeder is excluded.
9. The kitten has been vaccinated twice against FVR, Calicivirus, Panleukopenia, and rabies(once). Once they leave our premises the kitten and become exposed to various infectious diseases shown above through the air, other pets, or from your clothes or shoes when traveling in and out of your home, we will not be responsible for any kitten that should fall ill that has been led outside into the open world
10. If, at the insistence of the buyer, the kitten is purchased earlier than the deadline for departure (but not earlier than 16 weeks), the buyer is fully responsible for the health of this animal.

11. The buyer confirms that he has received detailed recommendations on the maintenance and care of the kitten. And undertakes to promptly inform the Breeder about all problems in the content, behavior, and health of the animal in order to resolve them collectively. In case of violation of these recommendations, the Breeder is not responsible for the condition of the kitten in the new home.

12. If the kitten or cat is returned to the cattery within first 30 days after the date of purchase(for any reason) the breeder will return \$250 only.

13. If at any time after the first 30 days the buyer can no longer take care of the kitten, the breeder agrees to accept the kitten back without an obligation to refund the purchase price.

14. Health guarantees will not be honored if ownership changes.

15. The breeder has to be notified first if you're planning to rehome the kitten and/or are unable to take care of it.

16. In case of Curlslux cattery closing all contracts are voided.

Further responsibility for the life and health of the kitten lies with the buyer.

To reserve the kitten a deposit of 20% of the total cost which would come out to \$520.00 would have to be paid. The Buyer undertakes to pay the remaining amount of \$2080.00 by. _____ and pick up the kitten. Date of making the deposit "___" _____ 2026. If the buyer refuses this animal, or if the terms of payment and the deadline for taking the kitten out of the cattery are not met, the breeder reserves the right to terminate the sales contract with the buyer and put the kitten up for sale, the deposit is not refundable.
